3. **Fee establishment for private pay citizens for specialized individual transportation**

Mayor George moved to establish a \$25.00 fare for private pay citizens to use for specialized individual transportation services when persons cannot use regular transit buses or when trips fall outside of regular transit trips and schedules, to be effective immediately. Commissioner Jackson seconded. Motion unanimously carried.

4. Consideration to purchase our building and property from Port of Columbia

Discussion was held. The board directed Guettinger to talk to the Port of Columbia and look into the cost and possibility of CCPT purchasing the building and property we are currently leasing from the Port.

5. Annual Performance Evaluation of the General Manager

Discussion was held.

The Board directed Guettinger to place on the agenda for the December meeting, a spot for a personnel evaluation of the General Manager by the Board


CCPT REPORTS AND CORRESPONDENCE
